Notice of Intent Application for the proposed ecological improvements of the West Branch of the Housatonic River through the removal of the Tel-Electric Dam, located on property associated with 150 Hawthorne Street (Map G8, Block 2, Lot 114), and the dredging of its impounded sediments. Such actions are proposed to occur within Land Under Waterways, Riverfront Area, Inland Bank, and Bordering Land Subject to Flooding. The applicant the City of Pittsfield.
