Continued – MassDEP File #263-1123: Notice of Intent Application for the proposed construction of a seasonal recreational boat facility and the removal of four trees on property located at 22 Waubeek Road (Map G16, Block 1, Lot 17). Such actions are proposed to occur within Land Under Waterbodies and buffer zone to Inland Bank associated with Pontoosuc Lake. The applicant is Pontoosuc Lake Properties, LLC.
- B. Notice of Intent Application for the structural replacements within an existing electrical transmission line corridor that include access road and work pad construction. The project is located within the Eversource Energy's F132 Line Right-of-Way. Such actions are proposed to occur within Bordering Land Subject to Flooding, Riverfront Area, and Bordering Vegetated Wetlands. The applicant is NSTAR Electric Company dba Eversource Energy.
- C. File #19-14 - Request for Determination of Applicability for the improvements to an existing farm road and the installation of subsurface utilities on property located at 973 Barker Road (Map D2, Block 2, Lot 101). Such work is proposed to occur within buffer zones associated with Bordering Vegetated Wetland and Inland Bank. The applicant is EOS Farms, LLC.
