Continued: Mass DEP File #263-1188: Notice of Intent application for the implementation of an Aquatic Plant Management Program for non-indigenous aquatic vegetation control within Pontoosuc Lake. Such activities are proposed to occur within Land Under Waterbodies. The applicant is the Town of Lanesborough and Friends of Pontoosuc Lake.
- B. Continued: Mass DEP File #263-1194: Notice of Intent application for the construction of two new building additions and new parking lot on property located at 100 Dan Fox Drive (Bousquet Sports Map G3, Block 1, Lots 3 and 201.) Such activities are proposed to occur within Inland Banks and associated buffer zones. The applicant is Bousquet Sport Enterprise, LLC.
